The undersigned proposes to furnish 2NS Sand (Winter Maintenance Sand) to the Board of Clinton County Road Commissioners in accordance with the requirements of the current Edition of the Michigan Department of Transportation Standard Specifications for Construction and the following specifications:

**GENERAL REQUIREMENTS**

The processed fine graded aggregate will be 2NS Sand meeting the current Michigan Department of Transportation's specifications with the following exceptions:

- 1- To be used as winter maintenance sand and will comply with the angularity index.

No additional modifications of the specifications will be made without the permission of the Managing Director of the Clinton County Road Commission. The undersigned will be responsible for testing material to guarantee specification compliance. If deemed necessary by the Clinton County Road Commission, an independent firm can be retained for testing of materials with the cost to be shared equally by the Road Commission and the supplier. The Clinton County Road Commission reserves the right to have a certified testing lab sample material from the grade and test for specification compliance at any time.

The undersigned has included a listing of three references of previous work experience including the company name, address, phone number, and contact person.

**LOCATION AND QUANTITY**

The bidder will be responsible for contacting the Managing Director or Superintendent of Operations of the Clinton County Road Commission and receiving prior approval for their proposed stockpile location.

The material shall be delivered to:

- o The Road Commission garage located at 3536 S. US Highway 27, St. Johns, Michigan.

The unit price shall be on a "per ton" basis delivered and stockpiled. Measurement shall be by weight tickets. A load ticket will be required for each load. All material shall be weighed on State certified platform scales. Material hauled may be subject to spot checks by Road Commission personnel. There will be no payment for material hauled which exceeds the legal load limit.

The estimated amount of 2NS Sand will be approximately 1,000 tons. This quantity could increase or decrease.

TIME OF DELIVERY

**All material shall be available to the Road Commission at the preapproved location by November 1, 2018. If this is not met a \$500.00/day penalty will be accessed.**

**Renewal Option:**

The Road Commission reserves the right to renew the contract for additional one-year terms. Each renewal to be mutually agreed upon by both parties. Pricing, terms and conditions of the first year of the contract will remain the same for any subsequent one-year renewal period.

PAYMENT

Payment will be made 30 days from the invoice date pending Road Commission approval.

INSURANCE REQUIREMENTS

Bidders must have valid certificate of Workers' Compensation Disability Insurance and Liability Insurance naming the "Clinton County Road Commission its Commissioners and Employees" as "additional insured" and shall be on file at the Road Commission office before work begins. Minimum requirements are:

Should the policy be canceled or expire, all activities authorized by this agreement shall cease.

The Road Commission reserves the right to accept any part or this entire bid that they feel is in the best interest of the road commission.

The bidder will be responsible for CDL compliance of all employees/sub contractors used in fulfilling the 2NS Sand (Winter Maintenance) transport.
