E. Information from County Commissioner David Pohl

Commissioner Pohl reported: 1) Condolences to Karla Gurski on the passing of her Father, 2) The restricted use of the Fair Grounds continues, 3) Pursuing a ventilation study for the Court House, 4) Approved the Spring & Fall Clean Community events, dependent upon COVID, 5) Received a communication from the construction company that managed the construction of the cheese plant that was very complimentary regarding the positive working relationships they experienced with multiple agencies within the County during the project, 6) COVID update, last report was over 2,300 confirmed cases and 20 deaths.

Discussed the rip rap issue, noted that MDOT will not participate in the \$50,000-\$100,000 cost to correct this. Will provide a DeWitt project update to post on Facebook and mail to residents who are impacted. 2) Design Updates: Continuing work on 2021 projects for next Spring, 3) 2020 Bridge inspections have been completed by Brechting along with a list of maintenance items for CCRC crews to address.

CONTAINING 0.45 ACRE, MORE OR LESS.
