E. Information from County Commissioner David Pohl

County Commissioner Pohl reported: 1) The County Commissioners have not met since the last Road Commission meeting but he gave a COVID update: over 3,000 cases and 30 deaths. COVID continues to impact the activities in the County.

G. Director of Engineering Report

Mr. Trotter reported: 1) Coleman Road: light poles to be installed next week, punch list items will carry into the Spring, projecting to use all the remaining project budget, 2) Church Rd Bridge: issued a notice to proceed, the Drain Commission signed the contract, contractor set to go, 3) Colony & US127 Safety: Tentative ROW permit approval, will require the full SHPO approval process, 4) Planning: Looking ahead for the next TIP cycle, 2023-2026, must be submitted in Sept 2021, will begin to identify potential projects. Discussed that we should prepared in case a stimulus project would become available, 5) Developments: Bonnie Meadows, all documentation in hand, no outstanding issues, Bingham Farms #4 will be seeking approval to break ground in the Spring, 6) Permitting: Request from Lansing Board of Water & Light to place wireless meter reading repeaters in ROW, Consumers Energy sent preliminary plans for major gas upgrade project in DeWitt Township, BR-27, Sheridan, Turner, State for 2021. Commissioner Holt questioned the development of a parcel on Dill Road just outside the DeWitt City Limits. The Dill Road parcel will be reviewed and reported on next meeting.

Mrs. Rey reported: 1) MTF for December was \$839,560.95, 2) Sick leave sell back paid out \$38,325.90, 3) Attended CRA Legal Issues Symposium, last session was excellent regarding Govt Immunity, 4) All projects have been invoiced for the year and have been paid timely, 5) Preparing final 2020 budget adjustment for next Board.
