County Commissioner Pohl reported: 1) County will receive \$15.4 million for COVID, unsure of how it can be spent, 2) Offered that it might be wise to stay with an Attorney who has previously bargained successful contracts, 3) Unable to attend the legislative breakfast

F. Public Comments

G. Director of Engineering Report

Mr. Trotter reported: 1) CONSTRUCTION: DeWitt & Clark Roundabout - starting on bridge work now, construction scheduled to begin April 1st, intersection will be completely closed until mid June, several detour routes will be posted. Continuing ongoing negotiation with

resident over easement, also working to improve drainage on SW corner; Herbison Road - K&R scheduled to start paving and sidewalk project March 29, approximate 2 months to complete; Church Rd - bridge will start as soon as seasonal weight restrictions are lifted, estimated to be a 2-3 week project as long as box culvert arrives on time; Coleman Rd - finishing up a few items, fence company cut gates into access the hydrants, will restripe the road with recessed pavement markings; Scott Rd - Crews will start soon, good prices during the bid process so will be a reasonable fix. DESIGN: Colony/127 - FHWA approval last week on track for next week; 2021 Chip seal submitted; Francis/Clark (2022) - Intersection safety improvements, will post RFP for design, will combine with Webster Rd (2023)- to contract for services as needed for multi year contract - unsure how much work will be needed at this point in time, will RFP for 2 companies; PLANNING: Bridge Load Rating - requested extension from MDOT to turn in scans and sketches of bridges. Currently there are not plans for more than half of the existing bridges. Sketches of bridges will need to be created and loaded into the system. This is a new requirement and a huge task, plans to utilize summer interns to assist with the project.

Mrs. Rey reported: 1) Audit in process, 2) Received requested information regarding future OPEB assumptions from Chris Veenstra, Actuary, will be presented to Board at a later date, 3) Katie Staley, PR/HR Clerk started the 15th, we welcome her to the CCRC team.

Mr. Steffen reported: 1) Covid update: Able to meet remote until March 30th unless County extends protocol; 2) Several township road tours scheduled, Met with Lee Thelen, Doug Riley, and new prosecutor Tony Spagnuolo to discuss road damage caused by mining operations and farms, Attended Ovid Township meeting; 3) He was voted onto the Board of the Association of Southern County Road Agencies; 4) Bingham Twp small urban funding discussion continues regarding DeWitt Road; 5) News articles pertaining to SSI being investigated by FBI; 6) Planning to have Bendzinski group present to Board next meeting regarding funding options for the proposed building project; 7) Legislative breakfast tomorrow @ 9:00 am.
