G. Information from County Commissioner David Pohl

Mr. Pohl reported: 1) The Scrap Tire Collection Event is being held September 25th, 2) Waste Management is having the Clean Community Event on October 16th at Granger, 3) The county did not extend emergency declaration beyond July 31st, if data indicates a need to revisit that decision we will address it at that time, 4) 911 project is currently on schedule, may run into an issue with chip shortage that could affect time line, 5) Lansing Economic Area Partnership (LEAP) provided an explanation of how they could assist the County in administering the ARP funds to help businesses that were significantly impacted by the COVID pandemic, 6) The Parks and Greens Space approved project at Clinton Lakes to pave the parking lot and beach development on the north and east side of Big Clinton Lake, plan to start after Labor Day.

H. Public Comments

Dan Coss with City of DeWitt: Wants to extend their thanks and appreciation on behalf of the City of DeWitt to Doug, Marc, and Jake on the completed projects with CCRC. Only having one hiccup on 4 million dollar project was amazing, and despite any issues with contractors, CCRC did a fine job and delivered a great product. The bike paths and sidewalks are used all the time, these are very appreciated by the public. Overall it was a

seamless project, and there was not one complaint from the downtown businesses during the project and we all really appreciate it.

Andrew Dymczyk: As the DeWitt Township Representative and a resident, the collaboration it took to achieve these projects was very much appreciated. The patience Marc and staff had with residents when navigating through opinions and any difficulty during the project was appreciated. The communication between CCRC and the Township & City made a huge difference.

### I. Director of Engineering Report

Mr. Trotter reported: 1) DeWitt Roads & Sidewalks: Andover Street - City cut down two trees, next K&R will be re-mobilizing Monday to hydro-vac remaining areas of concern, we will finish in 2 weeks if all goes well, 2) Colony/127 and Townsend & Krepps - both starting in September, 3) Chip Seals are finished, fog sealing & striping this week, 4) County Paving: Francis Rd-Grand River to Stoll - getting deferred to 2022 to coordinate with MDOT, Price & Colony is complete, 5) Township Paving: Watertown - Riverside & Looking Glass Bridge starting September 23rd, DeWitt - Boichot & Stoll starting in September, Greenbush Township - Scott Road will begin in September and October trying to coordinate with Federal Aid project, Bath - Hunsaker Drive is complete, Victor Township - Hollister Road completed today, 6) Pavement Markings; M&M is 90% complete with the county wide retrace, the new construction striping with go through October, 7) MDOT Bridge Bundling -Tallman & Herbison bridge construction is deferred to 2022, 8) As Needed Engineering RFP for pregualification for engineering consultants in 4 or 5 different categories, would like to put out for 2022 projects - Francis/Clark for survey & design assist. Grand River & Wood for NEPA & design assist. 2022 Bridge inspections, for 2023 projects: Webster Road for survey & design assistance for TAP/SRTS/Paving, Chandler Road for study & design assistance, and lastly for Corridor Studies on Airport, Clark and Chandler, 9) Planning: 2023 through 2026 TIP Projects, CCRC draft list and cost estimates presented and reviewed the list with our urban townships (DeWitt, Watertown, & Bath), 10) Tri-County: We completed the traffic counts in Clinton County and interns will be finished on August 20th, we will not get Ingham County done and Eaton County is handling their own, 11) For the Solon Speed Study CCRC collected preliminary speed data and turned that over to MSP, it showed reasonable speeds around 35-40 mph in the area of concern now we will wait for the MSP's recommendation, 12) Bath Township - Cherry Street Abandonment - we received a petition which was signed by all property owners, this was a paper road that never got developed, petition has signatures from all sides of the property plus required 7 freeholder signatures to expedite abandonment, with approval the property would revert back to adjoining property owners, 13) Developments: Thomas Farms in DeWitt Township submitted for preliminary plat approval, Phase 1A and 1B for the fall of 2021 and Phase 1C TBD, Bingham Farms - starting road work next week for Phase No. 4, Granger in DeWitt Township - working on site plan review for west entrance on Grange Meadows Drive, Culvers Restaurant and Northway Drive in DeWitt Township - Northway is currently a private drive, owners are evaluating turning it over as a public road, CCRC, DeWitt Township, and the Drain Office met last week to review the requirements to do so.

### J. Finance Director Report

#### Update:

Ms. Gurski reported: 1) MTF for June is \$1,035,219.34, which includes the \$10,000 engineering reimbursement, 2) Attended the first in-person Seven County Council Meeting - it was great to meet people and put faces to names, was also nominated to be the Secretary for the council, 3) The Workman Comp audit was completed on this last Thursday - everything went well, 4) Filed the annual Title VI certification (equal opportunity), 5) Attended the Southern Michigan Road Commission Finance & HR Association quarterly meeting on August 11th - discussed changes in how leases are recorded- GASB 87 - capital leases and operating leases all treated same now, 6) Have been networking more with others, which has been good and given some new insight on processes, 7) Karla and Doug have been enrolled as members of the Michigan Government Finance Officers Association, which provides educational programs/seminars in public finance, updates on pending legislation, new regulations, and accounting standards.

Meetings, 4) Marc and Doug met with Rowe last week to discuss DeWitt projects, 5) Had a successful Manager & Commissioner mid year workshop on August 9th, 6) MDOT Contract revised new contract updating language and requiring a 2-year period if a Road Commission wants to end the contract, 7) Talking with John. N. this next week to discuss planning, 8) Tracking new infrastructure package of possibly \$425 million over a 5-year period, 9) Letter from DeWitt School Staff regarding bus driver safety concerns - set up a meeting with the new school superintendent to sit down and go through everything, we will work with them on getting any issues resolved, 10) Andrea from Tri-County will be at next board meeting.

WHEREAS, a petition was received by the Board of Clinton County Road Commissioners to consider abandonment of a portion of Cherry Street (Road) Right of Way, located between Clinton Street and Main Street, within Bath Charter Township, Section 17, and

WHEREAS, a separate public hearing is not required based on Clinton County Road Commission Policy for Abandoning a Road (No. 116), the adjacent property owner(s) along with 7 freeholders of the Township have signed the petition, and the roadway does not cross or border on a waterway, and

WHEREAS, the Clinton County Board of Road Commissioners feels that abandonment of the portion of the Cherry Street (Road) Right-of-Way is in the best interest of the public, and said property will revert to the adjacent property owners,

NOW THEREFORE BE IT RESOLVED that the portion of the Cherry Street Right-of-Way, a 66' wide strip of land extending approximately 313.5' east from Clinton Street to Main Street located between Parcels:

10-100-014-004-00, S 3/4 of Lots 4 & 5, Block 14

010-100-014-006-00, Lots 6 & S ½ of Lot 7, Block 14 010-100-015-007-60, Lots 1, 2, 3, 4, 5, 7 & 8, and the S 1 Rod of Lot 9, Block 15 010-100-015-009-00, Lots 9 & 10, Exc the S 1 Rod of Lot 9, Block 15

as shown on the Plat of the Addition to the Village of Bath, dated Feb 1, 1895, be absolutely and permanently abandoned and dedicated to the adjacent property owners, any easements for public utilities lying within this right-of-way to remain unless abandoned by each public utility individually.
