- Searles Construction has paid us in full and the matter has been dismissed.
- We will be advertising bids for heavy materials next week on Bid Express.
- CRA distributed a study/publication on EV's to show legislatures the damaging impact they are having on road funding.
- The 2023 MSP agreement has been received increased road patrol when necessary.
- The Legislative Breakfast will be the sometime in the first week of March, once state senators and house representatives are confirmed we will set the date.
- Consumers Energy is not being responsive to emails or phone calls for our new facility, so their permits will be held and not approved until they get our new facility needs addressed.
