Federal Aid:

• The 2023 Federal Aid projects are on track. We recently received notice that the \$20,000 Soybean Grant for 2023 was approved to be used on DeWitt Road.

Paving:

Earlier this week, we received the HMA bids back for the county paving and they did come in slightly lower

than last year.

Design:

• We are continuing to work with Bengal Township on the replacement of the Dexter Trail box culvert. Bengal has approved to move forward with the design consultant.

Permits/ROW:

• The Forsberg project off of Stoll Road for Nottingham Fields needs to do the proper density testing before CCRC will accept the road.

- · Year-end processing continues.
- Cost share for 2023 went up about 3% overall from last year. Some townships amounts did go down slightly because of the 2020 census numbers now being used.
- We received the letter of engagement from Rehmann Robson, and we are looking at the week of March 13th for the audit.
- Staff & commissioners are signed up for the CRA Road Show on Wednesday, March 22nd.
