- Paving projects will be starting soon. April 24th Rieth Riley will be finishing the paving on the Grand River Avenue project. The county wide paving should begin on or around May 10th.
- The DeWitt Road crush and shape project will start around May 5th. The soybean rejuvenator will be applied once the pavement marking is done and has set for 2 weeks. The MI Soybean Association plans to host an event to showcase it, they are trying to put together a lunch-n-learn, where those that attend can see the process done and discuss.
- We have been meeting biweekly with the LRE consultant for PE services.
- Met with Bath Township last week, the SRTS project is on track, this will be a 2024 project.
- The two speed studies that came in at the end of last year for Wood Road and State Road will start back up now that the gravel trains are hauling.
