- Bath Township will be doing another paving project in Hawk Hollow on Gary & Timothy Lane.
- · Looking Glass & Ridgerock sidewalks will be done later this fall.
- CCRC will be repaving DeWitt Townships parking lot for them this fall.

Ms. Gurski reported:

- MTF for August (June fuel) was \$1,124,025.36, this includes our engineering reimbursement.
- The paperwork has been submitted for our workman's comp audit; it is virtual again this year so everything was uploaded to a portal.
- Getting dates scheduled with the moving company, phone company and IT vendors for our move to the new facility.
- We are working on our physical inventory count this week before the move to the new facility, and we will also being do a spot count on items after the move to ensure accuracy.

## I. Managing Director Report

Mr. Steffen reported:

- The new facility is coming together, the finishes touches will be completed in the next couple of weeks. The plumbing and electrical inspections are this week, with the mechanical and fire alarm inspections on Monday. If all goes well, the final building inspection will be on Tuesday.
- The furniture is being delivered tomorrow, with installation beginning Monday. Our scheduled move date is Tuesday, September 5th.
- We plan to have an open house possibly in November, the same day as our township officers meeting. We will also have a separate open house for staff and their families.
- We applied for the Bio-restore grant to apply a soy-based dust control, although we have not heard back yet, we were told that they liked our proposal.
- Karla has been in communication with MDOT regarding the state ear marked funds, making sure the proper paperwork is set.
- We will be getting design bids for the Chandler Road project in Bath Township. The DeWitt Road project is not as complex, and we can use our as needed consultants for the design.
- There were no extra funds received for the Airport Road project, so we will proceed with this being a rehab project.
- Jake & Marc did an analysis on the DeWitt Road project from M-21 to Price Road, the federal aid buyout money proved to be a good decision and we came out ahead, allowing us to use the funds further.
- The State police have the analysis information for the speed study that was done on Wood Road and State Road, a letter will be going out to the residence with the updated information.
